- 5. A GUARANTOR FORM COMPLETED BY A UK BASED GUARANTOR ALONG WITH A COPY OF THE GUARANTOR'S DRIVING LICENCE OR PASSPORT
- 6. CONFIRMATION THAT RENT PAYMENTS ARE SET UP

BEFORE HANDING OUT KEYS, ALL THE ABOVE CRITERIA MUST BE MET & THE FIRST RENTAL INSTALMENT PAID IN CLEARED FUNDS BY EACH TENANT

If any tenant signs the tenancy agreement & fails to comply with the conditions referred to above within the two week period then it will be at the landlord's discretion as to whether or not to treat the agreement as complete and binding upon whoever has signed & YOU WILL FORFEIT YOUR HOLDING FEE.
